Motion by Steve White to approve Covid Guidance Updates, employees will be subject to the updated CDC guidance for isolation protocols. If an employee is Covid positive they are required to isolate for 5-

days and may return to work on day six with improvement in symptoms and no fever. On days 6-10 the employee, regardless of vaccination status must wear a mask, second by LeRoy Staples-Fairbanks.
